I hereby release, covenant not to sue, discharge, and hold harmless Leadership Jacksonville, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating

thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Leadership Jacksonville, its employees, agents, contractors and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Youth Leadership Jacksonville program.

Additionally, I agree that I will not hold Leadership Jacksonville liable for a tuition refund, in full or in part, in the event that the content of the program is impacted by COVID-19 policies or restrictions.
