A. COVID-19 AGREEMENT AND WAIVER PARTICIPANT

By signing this Agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 while attending a Leadership Jacksonville program and that such exposure or infection may result in personal injury, illness, permanent disability, or death. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind (the "Claims"), that I may experience or incur in connection with my attendance or participation in the program. I hereby release, covenant not to sue, discharge, and hold harmless Leadership Jacksonville, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Leadership Jacksonville, its employees, agents, contractors and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Leadership Jacksonville program.

Additionally, I agree that I will not hold Leadership Jacksonville liable for a tuition or fee refund, in full or in part, in the event that the content of any program is impacted by COVID-19 policies or restrictions. I recognize that Leadership Jacksonville is committed to providing a quality

program that is safe for participants and this may require substantial changes in the typical Leadership Jacksonville program.
